

Contest Rules – Back to School Giveaway (Teachers)

1. NO PURCHASE NECESSARY. Open only to legal U.S. residents of Massachusetts, and First Citizens' Federal Credit Union (FCFCU) members. For a copy of these complete official rules, go to www.firstcitizens.org. Must be 18 years or older to enter. Promotion takes place from September 5, 2024 through September 6, 2024.
2. DESCRIPTION OF GIVEAWAY: The First Citizens' Federal Credit Union "Back to School Giveaway (Teachers)"
The contest is designed to give ONE entrant the opportunity to win a \$50 Visa Digital gift card OR a \$50 Purchase from the Teacher's Amazon Wishlist.

ENTRY: "Back to School Giveaway (Teachers)" will be posted on Facebook and Survey Monkey on September 5, 2024. The promotional period to submit your survey via Survey Monkey link for entry begins at the time the post is live on Thursday until Friday when the winner is announced. Winners will be announced on Friday, September 6, 2024, at 9AM. To enter: like & follow the FCFCU Facebook page, click the survey monkey link in the First Citizens' Federal Credit Union Facebook post and complete the survey with your contact information. First Citizens' will not notify Entrants whether their submissions have been approved or denied. No purchase or payment of any kind is necessary to enter or win. By entering the contest each entrant agrees to abide by these Official Rules.

3. ALTERNATE METHOD OF ENTRY: To enter the "Back to School Giveaway (Teachers)" without engaging with First Citizens' Facebook, hand-print on a 3" x 5" card: First Citizens' Federal Credit Union "Teachers" with your full name, address, ZIP code, daytime phone number, email address and birth date; then mail it, with first-class postage affixed, in a hand-addressed envelope no larger than 4 1/8" x 9-1/2" (#10 envelope) to First Citizens' Federal Credit Union, Attn: Marketing, 200 Mill Rd., Ste. 100, Fairhaven, MA. Limit one entry submission per outer mailing envelope. All entries must be postmarked by September 19, 2024. Sponsor is not responsible for damaged, lost, late, misdirected, postage-due, incomplete, or illegible entries. Facsimile and mechanically reproduced entries will not be accepted. All entries submitted become the sole property of First Citizens' Federal Credit Union and will not be returned. Prizes will be awarded at the end of the contest period. The odds of winning depend on the total number of eligible entries received. Participants agree to be bound by the Official Rules.
4. A total of one (1) winner will be selected. Winners will be announced on September 6, 2024. FCFCU reserves the right to substitute any prize with another prize of equal or greater value. First Citizens' Federal Credit Union employees, Board of Directors, Officers, or persons in their immediate family are not eligible.
5. Winners will be notified by Facebook post, direct message, phone, e-mail or mail the Friday, September 6, 2024. In the event of non-compliance, if the winner cannot be reached at the phone number on winner's account information, or if the prize notification is returned as unclaimed or undeliverable, the prize will be forfeited, and an alternate winner will be selected. Prize is not transferable. No prize substitutions.

6. FCFCU has the right to disqualify any submitted entry.
