

## Contest Rules – Thankful Giving, Who Are You Thankful For:

1. NO PURCHASE NECESSARY. Open only to legal U.S. residents of Massachusetts, and First Citizens' Federal Credit Union (FCFCU) members. For a copy of these complete official rules, go to [www.firstcitizens.org](http://www.firstcitizens.org). Must be 18 years or older to enter. Promotion takes place from November 1, 2020 through November 27, 2020.
2. DESCRIPTION OF GIVEAWAY: The First Citizens' Federal Credit Union "Thankful Giving, Who Are You Thankful For" Promotion is designed to give entrants ("Entrants") the opportunity to win a \$50 Visa Gift card for themselves as well as a \$50 Visa Gift for a person they are Thankful For. There will be one prize given away each Friday during the month of November 2020.
3. ENTRY: "Thankful Giving, Who Are You Thankful For" reminder/informational posts will be randomly posted every week in November 2020 on First Citizens' Federal Credit Unions Facebook page. To enter, simply post on YOUR Facebook page who and why you are thankful for this particular person and then TAG First Citizens' Federal Credit Union. First Citizen's will not notify Entrants whether their Submissions have been approved or denied. No purchase or payment of any kind is necessary to enter or win. By entering the promotion each Entrant agrees to abide by these Official Rules.
4. ALTERNATE METHOD OF ENTRY: To enter the Gift of Giving Contest without engaging with First Citizens' Facebook, hand-print on a 3" x 5" card: First Citizens' Federal Credit Union "Who Are You Thankful For" to Win!, your full name, address, ZIP code, daytime phone number, email address and birth date; then mail it, with first-class postage affixed, in a hand-addressed envelope no larger than 4-1/8" x 9-1/2" (#10 envelope) to First Citizens' Federal Credit Union, Attn: Marketing, 200 Mill Rd., Ste. 100, Fairhaven, MA. Limit one entry submission per outer mailing envelope. All entries must be postmarked by Nov 6<sup>th</sup>, Nov 13<sup>th</sup>, Nov 20<sup>th</sup> or Nov 27<sup>th</sup>, 2020. Sponsor is not responsible for damaged, lost, late, misdirected, postage-due, incomplete, or illegible entries. Facsimile and mechanically reproduced entries will not be accepted. All entries submitted become the sole property of First Citizens' Federal Credit Union and will not be returned. Prizes will be awarded at the end of the contest period. The odds of winning depend on the total number of eligible entries received. Participants agree to be bound by the Official Rules.
5. A total of one (1) winner per Friday will be selected. Winners for the week will be announced each Friday, Nov 6<sup>th</sup>, Nov 13<sup>th</sup>, Nov 20<sup>th</sup> and Nov 27<sup>th</sup>. FCFCU reserves the right to substitute any prize with another prize of equal or greater value. First Citizens' Federal Credit Union employees, Board of Directors, Officers or persons in their immediate family are not eligible.
6. Winner will be notified by Facebook, phone, e-mail or mail on Friday Nov 6<sup>th</sup>, Nov 13<sup>th</sup>, Nov 20<sup>th</sup> and Nov 27<sup>th</sup>. In the event of noncompliance, if the winner cannot be reached at the phone number on winner's account information, or if the prize notification is returned as unclaimed or undeliverable, the prize will be forfeited and an alternate winner will be selected. Prize is not transferable. No prize substitutions.
7. FCFCU has the right to disqualify any submitted entry. Acceptance of prize constitutes permission to use the winner's name, likeness, videotape, and photo for promotional and publicity purposes at no additional compensation unless prohibited by law. The prize winner is

solely responsible for any local, state or federal taxes, and any other fees or costs. By also accepting the prize, winner releases and agrees to hold harmless FCFCU; their distributors, affiliates, and subsidiaries; the service agencies and independent contractors of any of the above organizations; and their respective directors, officers, employees and agents, including advertising and promotion agencies, from any and all liability for any injuries, including personal injury, bodily injury (including without limitation wrongful death), property damage, or loss or damage of any other kind, arising in whole or in part, directly or indirectly, from acceptance, possession, use or misuse of the prize or participation in this sweepstakes or any sweepstakes-related activity.
